EPA 691: Seminar: The seminar topic taught is Measurement and Survey Research which was required in those years for the PhD in Educational Policy and Evaluation. It became an elective course more recently.

SPF 301: Culture and Schooling: This is a required course for many undergraduate majors in the Mary Lou Fulton Teachers College.

COE 502 Introduction to Data Analysis: This is a required course for both of Mary Lou Fulton Teachers College's PhD programs.

TEL 712 Mixed Methods of Inquiry: This course is required for Mary Lou Fulton Teachers College's degree program in EdD in Leadership and Innovation.

EPA 555 Translating Research for Educational Change: This is a required course for the MA in Educational Policy.
