



Before me, the undersigned authority, personally appeared Julie Leicht who, being by me duly sworn, deposed as follows:


My name is Julie Leicht (affiant), I am of sound mind, capable of making this affidavit, and personally acquainted with the facts herein stated:

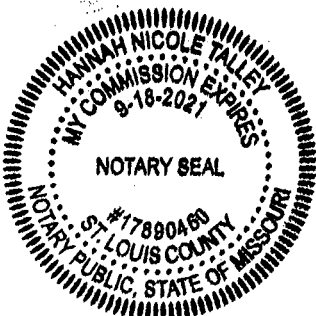
